Dear Working Interest Owners:

Yates Petroleum Corporation as Unit Operator of the North Dagger Draw Upper Penn Unit is ready to recommend the plugging and abandoning of the NDDUP #131 well located 660' FSL & 1980' FEL in Sec. 30-T19S-R25E, NMPM to the Working Interest Owners. Under Article 18 of the Unit Agreement, we are required to offer the well to the "Owners of the Spacing Unit" on which the well is located. Some of the owners of the spacing unit including Yates Petroleum Corporation and Nearburg Exploration Company, L.L.C., have elected to take over the well.

Under Article 18 Yates Petroleum Corporation as operator shall credit the joint account the amount determined to be the net salvage value of the casing and equipment in the well.
