Mewbourne Oil Company applies for an order amending the Special Rules for the Santo Nino-Bone Spring Pool, Eddy County, New Mexico, and in support thereof, states:

1. The Santo Nino-Bone Spring Pool was created by Division Order R-8546, and currently includes, or is projected to include, the following acreage:

Township 18 South, Range 30 East, N.M.P.M.

Section 19: SE/4
Section 29: W/2
Section 30: W/2 and W/2SE/4
Section 31: NE/4 and S/2
Section 32: All

2. The Special Rules for the Santo Nino-Bone Spring Pool provide for 80 acre spacing, wells to be located within 150 feet of the center of a quarter-quarter section or lot, and a depth bracket allowable of 310 barrels of oil per day.

3. Applicant is an operator in the Santo Nino-Bone Spring Pool.

4. Applicant requests that the Special Rules for the Santo Nino-Bone Spring Pool be amended to allow wells to be located no closer than 330 feet to a quarter-quarter section line. All other provisions of the Special Rules will remain the same.

5. Approval of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order granting the relief requested above.
