

Pursuant to NMSA 1978 §70-2-8 (1996) and Division Rule 1211, you are hereby ordered to appear at 8:15 a.m. on Thursday, July 8, 1999, at the offices of the New Mexico Oil Conservation Division, 2040 South Pacheco Street, Santa Fe, New Mexico 87505, and produce the documents and records described below, and make them available for inspection and copying by employees or representatives of Gillespie Oil, Inc.:

DOCUMENTS TO BE PRODUCED: All documents, records, and data regarding the matters itemized below, in your possession or under your control, pertaining to the Beadle Well No. 1, located in the W½SW¼ of Section 35, Township 15 South, Range 35 East, N.M.P.M., Lea County, New Mexico:

1. Reservoir pressure data including, but not limited to, bottom-hole pressure surveys or pressures, pressure buildup tests, surface pressure readings, daily tubing pressures and casing pressures, drill stem tests, with relevant information as to shut-in times and production rates before shut-in;

2. All production data on a daily basis from initial testing and completion to date, showing actual production of oil, gas, and water;
3. Mechanical (electrical and radioactivity) logs, and information on perforated intervals; and
4. Specific gravity information on liquids produced from the subject well.

INSTRUCTIONS: This subpoena requires the production of all information described above available to you or in your possession, custody, or control, wherever located. The information shall include data from commencement of drilling the well to the latest available data.

"You" or "your" means Energen Resources Corporation and its employees, former employees, officers, directors, agents, contractors, representatives, and affiliated companies.
