**STATEMENT OF CASE**

**APPLICANT**

Doyle Hartman here applies for establishment of minimum allowables of 600 MCF/D per acreage factor of 1.0 in the Jalmat Gas Pool. The Jalmat Pool's gas reserves represent a very substantial and valuable economic resource to the State of New Mexico and must be continued to be developed in an orderly manner. The current allowables for the Jalmat Pool do not accurately reflect market demand for gas from the Pool and are so low and unpredictable as to discourage some producers from additional development and artificially suppress production. A minimum allowable is necessary to achieve optimum pool development, to protect correlative rights, to prevent waste and will result in the recovery of gas that would otherwise not be produced.


