**STATEMENT OF CASE**

**APPLICANT:**

Meridian Oil Inc. seeks Division approval to pool all mineral interests in the Pictured Cliffs formation underlying the NM/4 and all mineral interests in the Basin Fruitland Coal Gas Pool underlying the W/2 of Section 18, T27N, R9W, NMPN, San Juan County, New Mexico, forming standard 161.32-acre and 322.40-acre spacing and proration units.

Said units are to be dedicated to Meridian Oil Inc.'s Lodewick Well No. 1 which is an existing Pictured Cliffs well currently approved by Order R-10090 for downhole commingled production from the Fulcher Kutz-Pictured Cliffs Gas Pool and the Basin-Fruitland Coal-Gas Pool at an unorthodox coal-gas well location in Unit D of said Section 10.

Also to be considered will be the costs of participation in said well, including but not limited to the value of the existing wellbore, the costs of recompletion, and the allocation of those costs and income as well as actual operating costs and charges for supervision, and the designation of applicant as the operator of the well.


