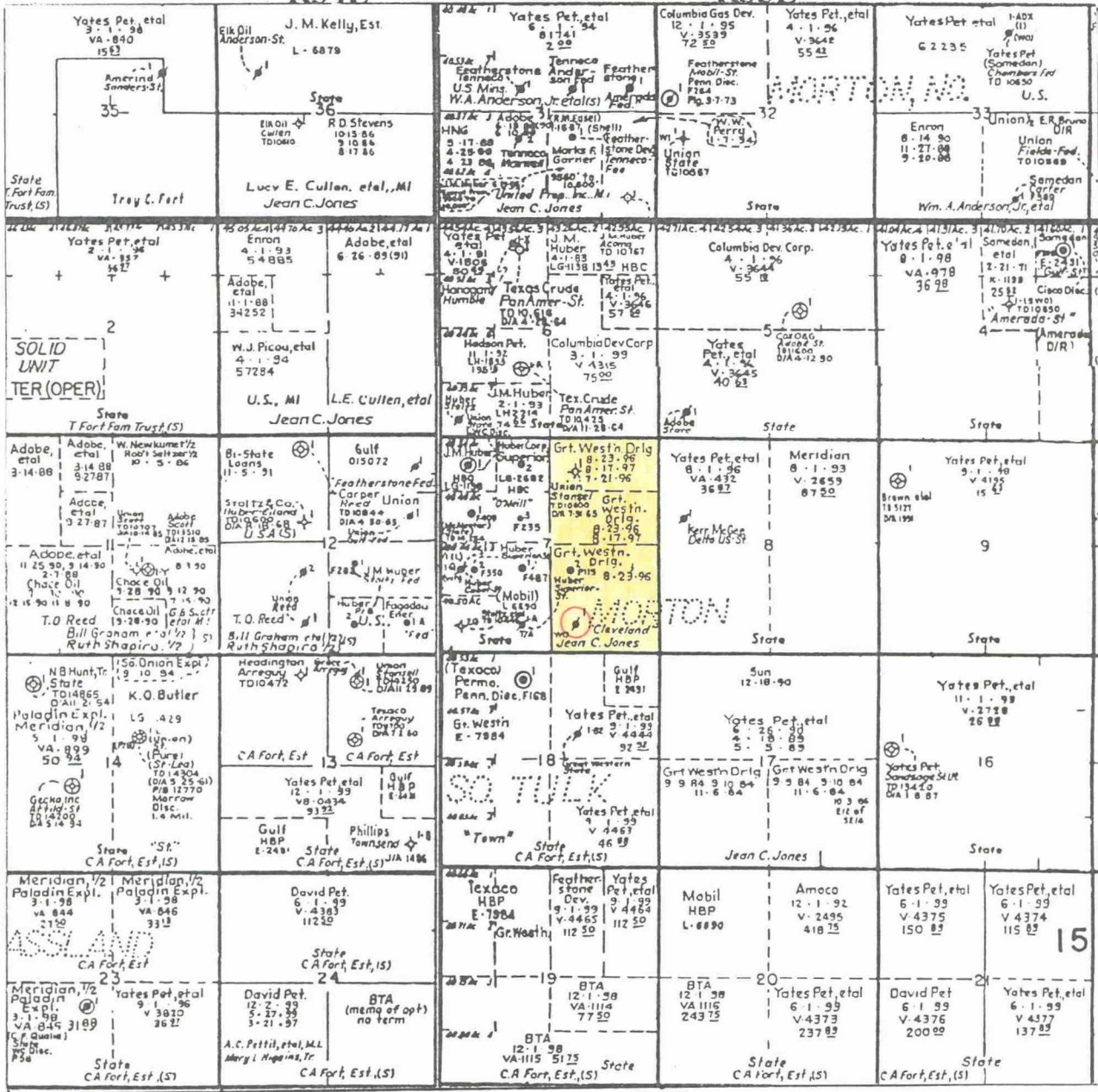

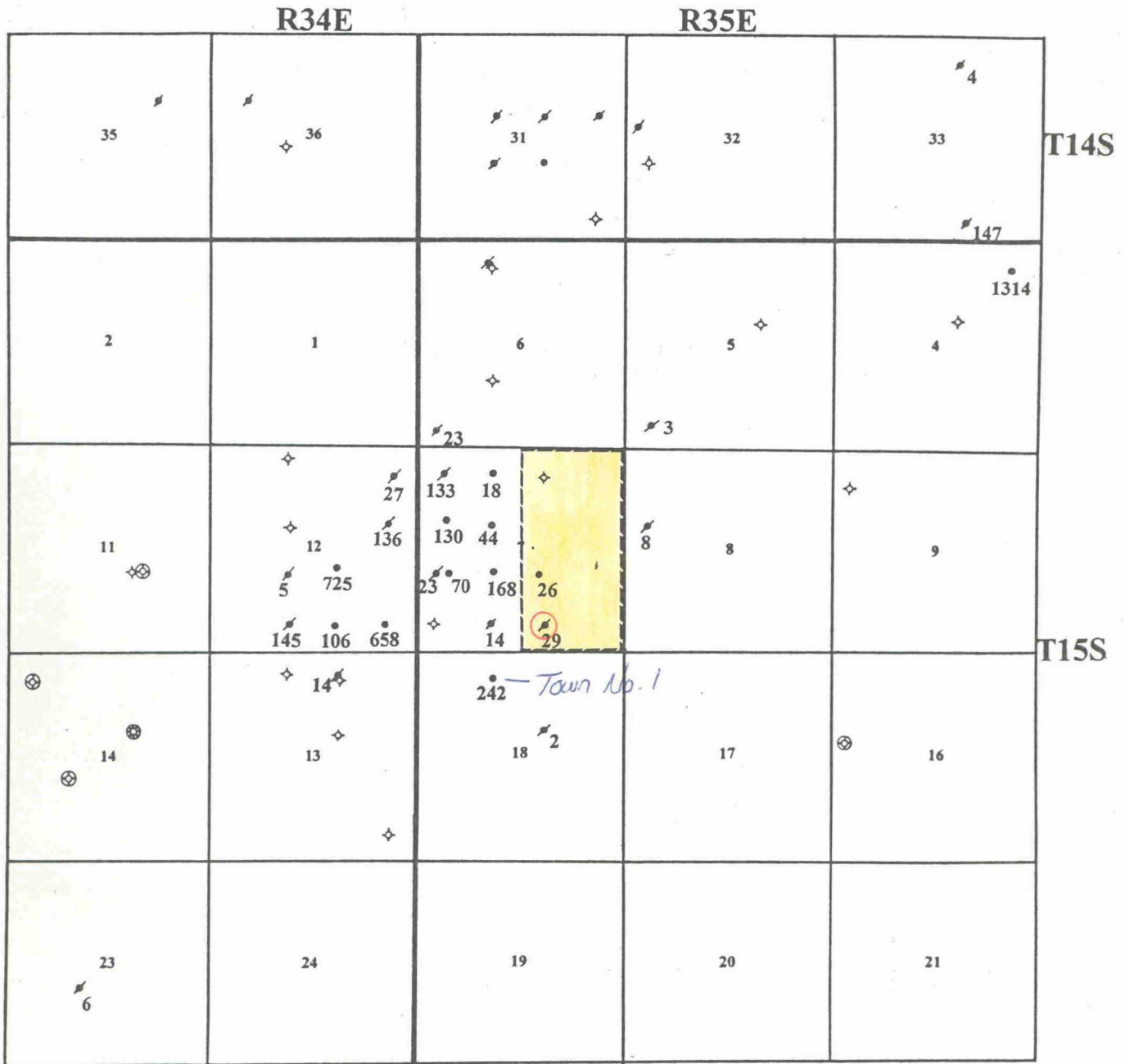
GLENN CLEVELAND #1
