STATEMENT AND EXHIBIT:

This statement is made in support of the application for Approval of an Unorthodox Location to drill a well to produce oil and natural gas from the Strawn Formation in the South Humble City Field of Lea County, New Mexico. The subject well is the proposed:

Lottie York #3
2030' FSL & 2300' FWL in Section 14, T.17S., R.37E. N.M.P.M.
Lea County, New Mexico.

The Bonneville Fuels Corporation has requested the proposed surface location of the Lottie York #3 on the basis of our analysis of geological (off-set well logs, structural and stratigraphic) data, geophysical (seismic) data, and directional drilling (gyro survey) data in the area. This analysis, at a cost of approximately \$175,000, has resulted in what Bonneville Fuels Corporation believes to be the geometric definition of the proposed reservoir target.


The Porosity Isopach Exhibit indicates the narrow and steep sided nature of the Upper Strawn Fm. reservoir structure in this area. The proposed location was selected to significantly improve the opportunity to intersect the FULL PRODUCTIVE THICKNESS of the Upper Strawn Fm. reservoir in the spacing unit.

Volumetric analysis estimates, based on the Porosity Isopach Exhibit, indicate 618,000 Bbl. of oil and 0.9 BCF of natural gas recoverable reserves for the proposed Lottie York #3 Well. To the extent that the proposed wellbore does not intersect the maximum productive thickness the ability of the well to recover these recoverable reserves may be reduced. This would result in the less efficient recovery (waste) of the hydrocarbon resources in place.

In support of this Unorthodox Location request it should also be said that:

1. The proposed surface location is not as close to the northern lease line as would be allowed within the Orthodox drilling window (2130' FSL vs. the requested 2030' FSL).
2. The operator, ownership and working interests are identical in this proposed proration unit and the proration unit immediately to the east - toward which the proposed well location does encroach (see the Land Plat Exhibit).






