ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on May 18, 1995, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 24th day of May, 1995, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Bone Spring formation, said pool to bear the designation of West Magruder-Bone Spring Gas Pool. Said West Magruder-Bone Spring Gas Pool was discovered by the Yates Petroleum Corporation South Avalon "MA" Federal Com. Well No. 1 located in Unit I of Section 14, Township 21 South, Range 26 East, NMPM. It was completed in the Bone Spring formation on December 16, 1994. The top of the perforations is at 5944 feet.

(3) There is need for certain extensions to the South Burton-Yates Gas Pool, the South Carlsbad-Morrow Gas Pool, the North Dagger Draw-Upper Pennsylvanian Pool, the Dagger Draw-Wolfcamp Gas Pool, the Indian Basin-Morrow Gas Pool, the Ingle Wells-Delaware Pool, the Laguna Salado-Atoka Gas Pool, the Mesa Verde-Delaware Pool, the P.J.-Delaware Pool, the Palmillo-Cisco Gas Pool, the Power-Grayburg-San Andres Pool,

and the Siegrest Draw-Abo Pool, all in Eddy County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico, classified as a gas pool for Bone Spring production is hereby created and designated as the West Magruder-Bone Spring Gas Pool, consisting of the following described area:

(b) The South Burton-Yates Gas Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:



IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.


(2) The effective date of this order and all creations and extensions included herein shall be June 1, 1995.
