Dear Mr. LeMay:

On July 6, 1995, the Commission issued Order #R-7285-A, Case #11317 heard in Hobbs, New Mexico, by Mr. Stogner, which allowed for an unorthodox location and compulsory pooling in the:

Norris #4 Well W/2SW/4 Section 13-17S-37E Lea County, New Mexico

To be effective, it was required that said well must be commenced by October 1, 1995.

On September 27, 1995 you granted an extension of this Division Order No. R-7285-A until December 31, 1995, at the request of Mr. David Spelman, Landman, of the Bonneville Fuels Corporation.

Bonneville Fuels Corporation, as operator, still intends to drill said well, but it appears unlikely that it will be able to commence actual drilling operations prior to January 1, 1995. Bonneville Fuels Corporation has a drilling contract with Peterson Drilling Company to drill the Norris #4 well and was previously informed that a rig with sufficient capacity to drill the well would be available to meet our commitment and commence drilling operations on approximately December 15, 1995. Bonneville Fuels Corporation has now been informed that a Peterson Drilling Company Rig with sufficient mechanical capacity to drill this well will not be available until approximately January 15, 1996 or February 1, 1996. Bonneville Fuels prefers to drill this well with experienced Peterson Drilling Company personnel at the favorable rates of the existing contract, if at all possible.

Bonneville Fuels Corporation hereby requests an extension under said order to allow for the well to be commenced any time prior to March 1, 1996. As we discussed on November 29, 1995, by telephone, this will be our last extension and drilling of said well MUST COMMENCE prior to March 1, 1996 or the Division Order No. R-7285-A will lapse.

It is the intention of the Bonneville Fuels Corporation to commence drilling of this well ON OR BEFORE March 1, 1996 - with or without the assistance of the Peterson Drilling Company, should they be unable to provide us a rig with sufficient capacity to drill the well prior to the lapse of this Division Order on March 1, 1996.
