AMENDED APPLICATION

COMES NOW ARCH PETROLEUM INC., by its undersigned attorneys, hereby makes application to the Oil Conservation Division for an Order approving seven unorthodox infill oil well locations, and in support thereof states:

1. Applicant is the operator of the hereinafter identified oil spacing units in Sections 21, 22 and 28 of Township 23 South, Range 37 East, N.M.P.M., Lea County, New Mexico and proposes to drill infill oil wells on the seven existing spacing and proration units in the Blinebry formation, Teague-Blinebry Pool as follows:

C.E. Lamunyon #51, 1300' FNL and 560' FEL, NE/4 NE/4 (Unit A) Section 21
C.E. Lamunyon #52, 1300' FNL and 2210' FWL, NE/4 NW/4 (Unit C) Section 21
C.E. Lamunyon #53, 1300' FSL and 330' FWL, SW/4 SW/4 (Unit M) Section 22
C.E. Lamunyon #54, 1300' FNL and 660' FWL, NW/4 NW/4 (Unit D) Section 22
C.E. Lamunyon #55, 2620' FNL and 330' FWL, SW/4 NW/4 (Unit E) Section 22
C.E. Lamunyon #56, 1300' FNL and 1300' FEL, NE/4 NE/4 (Unit A) Section 28
Saltmount #3, 990' FSL and 1300' FEL, SE/4 SE/4 (Unit P) Section 21


2. Approval of this application will afford Applicant the opportunity to produce its just and equitable share of the oil and gas from the Blinebry formation and will otherwise

be in the best interest of conservation, the protection of correlative rights and the prevention of waste.
