



1           WHEREUPON, the following proceedings were had at  
2 9:00 a.m.:

3           CHAIRMAN LEMAY: Good morning, welcome to the Oil  
4 Conservation Commission hearing. My name is Bill LeMay,  
5 Chairman of the Commission. To my left, Commissioner Bill  
6 Weiss. To my right, Commissioner Jami Bailey representing  
7 the Commissioner of Public Lands. Welcome to our hearing.

8           We will start with some business.

9           Fellow, Commissioners, you've seen the minutes,  
10 have you?

11          COMMISSIONER BAILEY: Yes.

12          CHAIRMAN LEMAY: Do you agree to sign the  
13 minutes?

14          COMMISSIONER BAILEY: Well, I motion for approval  
15 of the minutes --

16          CHAIRMAN LEMAY: Thank you.

17          COMMISSIONER BAILEY: -- of the least hearing.

18          CHAIRMAN LEMAY: Thank you, Commissioner Bailey.

19          COMMISSIONER WEISS: Yes, I agree.

20          CHAIRMAN LEMAY: Commissioner Weiss, do you  
21 agree?

22          We'll take final action on the minutes.

23          The signing of Order Number R-10,470, which are  
24 the Rules and Regulations -- Rule 303 of our General Rules

3 submitted, Order dealing with Rule 303? Commissioner  
4 Bailey?

5 COMMISSIONER BAILEY: Yes, it is.

6 CHAIRMAN LEMAY: Commissioner Weiss?

7 COMMISSIONER WEISS: Yes, it is.

8 CHAIRMAN LEMAY: And it's also my intention to  
9 take final action on Rule 303 for signing.

10 And finally, we have the order dealing with  
11 Application of Exxon for a CO<sub>2</sub> and waterflood project,  
12 Case Number 11,298 and Case Number 11,297, Order Number  
13 10,460-B. Is it your intention to take final action  
14 signing this order? Commissioner Bailey?

15 COMMISSIONER BAILEY: Yes, it is.

16 CHAIRMAN LEMAY: Commissioner Weiss?

17 COMMISSIONER WEISS: Yes.

18 CHAIRMAN LEMAY: And it is my intention also.

19 So with those three items, the Commission has  
20 taken final action on those three items.

21 Let's see, is there anything else that either one  
22 of you Commissioners have? We can get into the program.
