STATEMENT OF CASE

Applicant:

Applicant requests two unorthodox oil well locations in Section 28, Township 24 South, Range 29 East, for the following wells:

(1) The Cedar Canyon 28 Fed. Well No. 1, at an unorthodox oil well location 230 feet from the North line and 2510 feet from the West line (Unit C) of Section 28, with the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 28 dedicated to the well; and (2) the Cedar Canyon 28 Fed. Well No. 2, at an unorthodox oil well location 2410 feet from the North line and 2310 feet from the East line (Unit C) of Section 28, with the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 28 dedicated to the well. Each well will test the Bone Spring formation (First Bone Spring) and the Delaware formation (Undesignated Cedar Canyon-Delaware Pool).

The locations are based on topography. The wells are on a lease which will expire on December 31, 1995 unless actual production is established by that date. Thus, Pogo has set these matters for hearing to ensure timely approval in the event there is an objection to the locations.


