Ladies and Gentlemen:

The following minority and underproduced working interest owners in the Hill Federal #2Y Well respectfully request that this letter be placed of record in Southland Royalty Company's (hereinafter referred to as "Meridian") Application for Compulsory Pooling for all mineral interests in the Blanco Mesaverde Gas Pool underlying the N/2 of Section 25, Township 25 North, Range 2 West, forming a standard 320-acre gas and proration unit. The following summarizes the position of the minority and underproduced working interest owners concerning Meridian's proposal to plug and abandon the Gavilan-Mancos interval and recomplete the Hill Federal #2Y Well in the Mesaverde formation:

- O The last gas sales from the Hill Federal #2Y Well were in July, 1990. It has taken over 5 years for Meridian, as operator, to prepare gas balancing and cash settlement proposals for the allocation of gas volumes due to the underproduced owners from the overproduced owners. Since Meridian's overproduced position represents 93.16% of the total overproduced owners (\$39,604.72 of \$42,511.40 owed pursuant to Meridian's records), we request that the NMOCD issue in its findings that the Hill Federal #2Y Well be cash settled with all working interest owners before recompleting and producing from the Mesaverde interval.
- Meridian has requested approval from the minority and underproduced working interest owners to amend the Operating Agreement governing the wells operations for the Basin Dakota and Gavilan-Mancos formations to cover the Mesaverde formation. The proposal is totally unacceptable to the undersigned minority and underproduced working interest owners due to Meridian's track record in operating in the Hill Federal #2Y Well. To protect the correlative rights of the parties now owning the Hill Federal #2 Well and equipment, we would encourage the use of the following language in the event the NMOCD issues a force pooling order for the Mesaverde interval:
