SYNOPSIS OF ADOPTED RULES

The New Mexico Oil Conservation Commission (OCC) conducted a public hearing on January 18, 1996, concerning revision of its rules and regulations to comply with the New Mexico Administrative Code (NMAC).

The OCD reformatted its rules in order to comply with the new New Mexico Administrative Code mandated by 14-4-7.2 NMSA 1978. At the same time minor typographical, numbering and grammatical corrections were made to the rules. No substantive changes were made. The OCD rules will now be found as shown in the table below:


