

5 April 4th, 1996. I'm Michael Stogner, appointed Hearing

7 At this time I'll call Case Number 11,502.

8 MR. CARROLL: Application of Conoco, Inc., to
9 amend Division Order Number R-10,476 for an additional
10 unorthodox gas well location, Rio Arriba County, New
11 Mexico.

12 EXAMINER STOGNER: The Division Order Number
13 R-10,476 authorized downhole commingling of Basin-Dakota
14 and Blanco-Mesaverde gas production within 14 existing and
15 17 proposed wells within a certain unit located in
16 Townships 27 and 28 North and 7 West, all operated by
17 Conoco.

18 Well Number 159-M, that unit well, was to be
19 drilled at an unorthodox infill gas well location. That
20 location had changed subsequent to the issuance of Order
21 10,476.

22 Essentially, there are no notification
23 requirements, other than just correcting that in the


