To: All Operators in North Dagger Draw Upper Pennsylvanian Pool

Subject: OVERPRODUCTION (Case No. 11525; Order No. R-4691-E)

Date: January 2, 1997

The above subject order sub part No. 4 requires that the District Supervisor of the Oil Conservation Division's Artesia Office provide a list of all proration units that are overproduced to all operators of said pool. Attached are three listings of units of overproduction. By copy of this letter, each operator with overproduction is to verify the unit and total overage for the stated period as shown on the attached. Please sign, date and return this to the District Office.

The overproduction is to be made up at a rate of 350 BOPD (overproduction/350 = number of days at reduced rate) starting from a date of 9/19/96. Any production over 350 BOPD will be overproduction and will be added to the total overage that is to be made up. Any unit that has not made up the overage in an 18 month period from 8/15/96 shall be shut in for a number of days that equals the remaining overage divided by 700 BOPD. In addition, such remaining overproduction shall then be labeled as "illegal oil and/or gas" under the terms of any and all applicable Division rules and regulations and laws of New Mexico and the Division shall take appropriate action to prosecute such offenders.
