7 Bailey representing the Commissioner of Public Lands.

10 Have you fellow Commissioners looked at the

12 sign the minutes -- to approve the minutes, I should say?

13 COMMISSIONER BAILEY: It's my intent to approve,

18 So moved. The minutes have been approved.

19 Also, we have on the docket for final action
20 Cases Number 11,525 and 11,526, both of which are *de novo*
21 cases, Yates Petroleum for amendment of special pool rules,
22 North Dagger Draw, cancellation of overproduction.

23 Is it your intent to take final action and
24 approve the order on those cases, Commissioner Bailey?

25 COMMISSIONER BAILEY: Yes, it is.

1 CHAIRMAN LEMAY: Commissioner Weiss?

2 COMMISSIONER WEISS: Yes.

3 CHAIRMAN LEMAY: Final action will be taken on
4 those two cases.

5 And then case Number 11,563, which we ruled from
6 the bench, there is an Order on that case. Is it your
7 intent to take final action on that, Commissioner Bailey?

8 COMMISSIONER BAILEY: Yes, it is.

9 CHAIRMAN LEMAY: Commissioner Weiss?

10 COMMISSIONER WEISS: Yes.

11 CHAIRMAN LEMAY: Okay, thank you. Let the record
12 show that final action has been taken on Cases 11,525,
13 11,526, 11,563.
