4 Conservation Commission. My name is Bill LeMay. To my
5 left Commissioner Bill Weiss, to my right Commissioner Jami
6 Bailey representing the Commissioner of Public Lands, State
7 of New Mexico. Welcome.

8 I think we'll start today by doing a little
9 business.

10 Is there a motion for acceptance of the minutes
11 of the previous meeting?

12 COMMISSIONER BAILEY: So move.

13 CHAIRMAN LEMAY: Second?

14 COMMISSIONER WEISS: Second.

15 CHAIRMAN LEMAY: Thank you. The minutes have
16 been approved.

17 We have, I know, advertised two orders for final
18 action. Because of some last-minute, haven't-gotten-it-
19 ready-type things, and also a little bit of corrections
20 that need to be done, the action on the -- it was referred
21 to as Rule 19 -- is that right, Commissioner? Rule 19?

22 COMMISSIONER BAILEY: Yes.

23 CHAIRMAN LEMAY: -- which has to be changed, we
24 have a Rule 19. But as advertised, that will be postponed,
25 final action on that, until the November 14th hearing.

1 We do have listed final action on the Application
2 of the Oil Conservation Commission -- or the Division,
3 Application of the Division to amend Rule 1115, providing
4 for electronic filing, mandatory electronic filing.

5 Have you read the Order? Is it your intention to
6 sign the Order, Commissioner Bailey?

7 COMMISSIONER BAILEY: Yes, it is.

8 CHAIRMAN LEMAY: Commissioner Weiss?

9 COMMISSIONER WEISS: Yes.

10 CHAIRMAN LEMAY: Let the record show that final
11 action will be taken or has been taken at this Commission
12 hearing on Case Number 11,551, Order Number R-10,691,
13 pertaining to mandatory electronic filing for C-115s.
