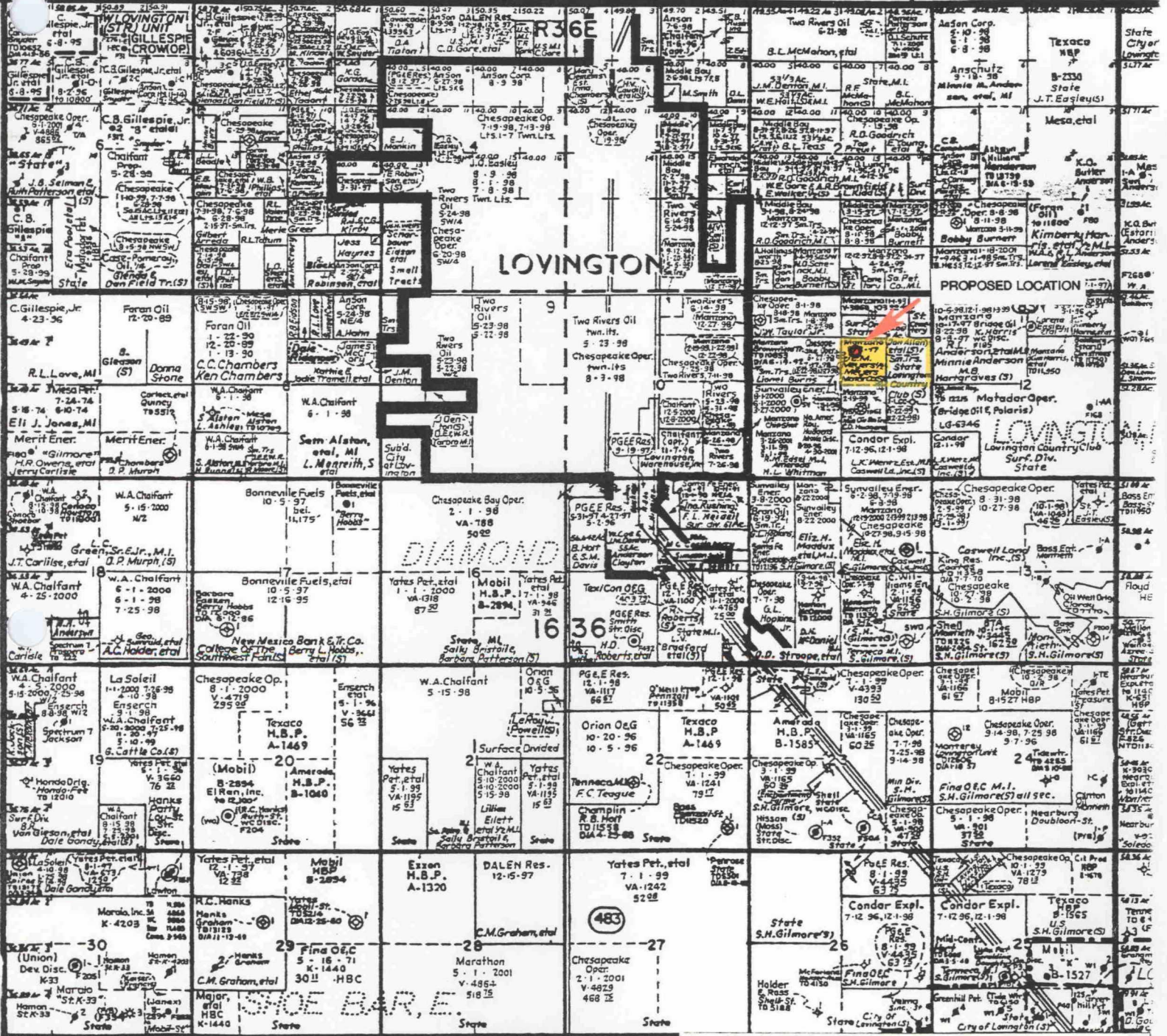
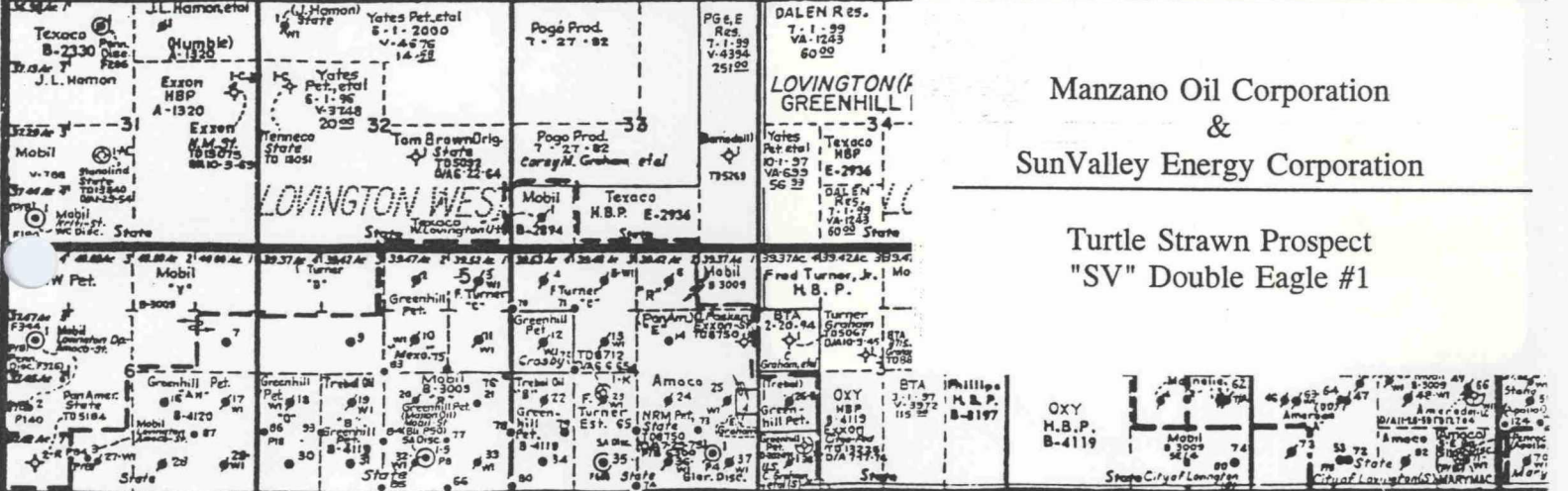


Alternatively, you may elect to not participate in the drilling of the well. If you should so decide we request that you grant an Oil and Gas Lease under the following terms to us.

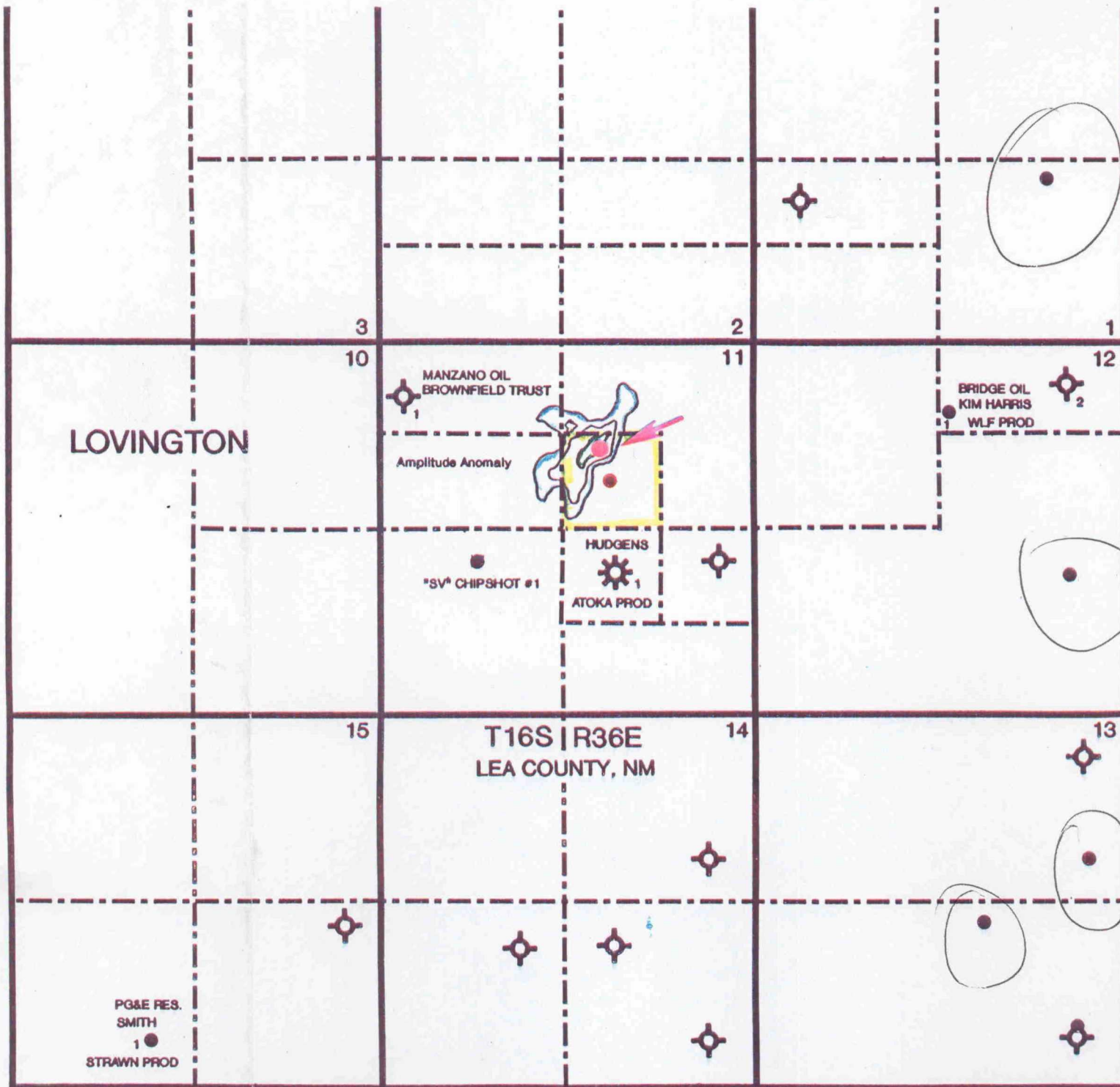
