

Gentlemen:

Reference is made to your application for approval of a 320acre non-standard gas provation unit in the Europat Gas Pool consisting of the following acreage:

It is understood that this unit is to be dedicated to your Devenian-State Well No. 1, located 1980 feet from the North and East lines of said Section 20.

Citation Oil & Gas Corp. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

Citation plans to drill and complete the **Devonian State Com. No. 2** in the Eumont Yates 7 Rivers Queen (Pro Gas) Pool. It is our desire to also simultaneously dedicate the existing 320-acre Eumont Gas Proration Unit assigned to our Devonian State Com. No. 1 [Administrative Order NSP-488] to three wells, the Devonian State Com. No. 1, the Devonian State Com. No. 2 and the Devonian State Com. No. 3. The latter well is covered in a separate application.

As a result, the proposed location of the Devonian State No. 2 of 710' FSL & 660' FEL, Unit Letter P of Section 20, T21S, R36E, NMPM, Lea County, New Mexico is unorthodox.

In order to prevent waste, Citation respectfully requests your approval of this administrative application for an unorthodox gas well location and simultaneous dedication. Attached is a map showing offset operators and a series of Form C-102 plats showing the location of the wells to be dedicated to this 320-acre Eumont Gas Proration Unit. A copy of this letter and attachments, along with waiver to objection forms are being furnished by Certified Mail to offset operators as their notice of this application.
