Dear Mr. Carr:

On behalf of CT-R, Ltd. Company and Chantrey Corporation, you are hereby requested to comply with the New Mexico Oil Conservation Division Memorandum 2-90 dated April 30, 1990 concerning the preparation, filing and serving of a prehearing statement.

I had hoped to avoid writing this letter but, despite my requests to the contrary, your firm continues to file prehearing statements which:

(1) instead of setting forth the issues in dispute and summarizing the evidence you intend to introduce, you complete the "Statement of the Case" portion of the form by simply duplicating the same language as appears in the OCD docket; and


(2) instead of delivering me a copy of the prehearing statement (my office is less than 100 yards from your office) you chose to have your secretary mail me a copy which often causes me to receive your prehearing statement after the hearing is over.
