ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on November 21, 1996, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 26th day of November, 1996, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Strawn formation, said pool to bear the designation of Empire-Strawn Gas Pool. Said Empire-Strawn Gas Pool was discovered by the Chi Operating Inc. Empire "16" State Com. Well No. 1 located in Unit E of Section 16, Township 18 South, Range 29 East, NMPM. It was completed in the Strawn formation on April 18, 1996. The top of the perforations is at 10,087 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation

of Herradura Bend-Bone Spring Pool. Said Herradura Bend-Bone Spring Pool was discovered by the Ray Westall River Bend Well No. 1 located in Unit G of Section 25, Township 22 South, Range 27 East, NMPM. It was completed in the Bone Spring formation on April 26, 1996. The top of the perforations is at 7,674 feet.

(4) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of East Illinois Camp-Bone Spring Pool. Said East Illinois Camp-Bone Spring Pool was discovered by the Harvey E. Yates Company Travis State Well No. 1 located in Unit K of Section 13, Township 18 South, Range 28 East, NMPM. It was completed in the Bone Spring formation on February 23, 1996. The top of the perforations is at 6,202 feet.

(5) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of oil from the Devonian formation, said pool to bear the designation of Northeast Long Arroyo-Devonian Pool. Said Northeast Long Arroyo-Devonian Pool was discovered by the Marbob Energy Corporation Ramos Fee Well No. 1 located in Unit G of Section 33, Township 12 South, Range 28 East, NMPM. It was completed in the Devonian formation on September 9, 1996. The top of the perforations is at 8,169 feet.

(6) There is need for certain extensions to the Northeast Chisum-Devonian Pool in Chaves County, New Mexico, and the Dublin Ranch-Morrow Gas Pool, the Empire-Atoka Gas Pool, the Happy Valley-Strawn Gas Pool, the North Illinois Camp-Morrow Gas Pool, the Ingle Wells-Delaware Pool, the South Los Medanos-Wolfcamp Pool, the East Loving-Brushy Canyon Pool, the Millman-Wolfcamp Gas Pool, the East Pierce Crossing-Bone Spring Pool, the Sand Tank-Morrow Gas Pool, the Santo Nino-Bone Spring Pool, the South Sulphate Draw-Delaware Pool, the Winchester-Morrow Gas Pool, and the Winchester-Wolfcamp Gas Pool, all in Eddy County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico, classified as a gas pool for Strawn production is hereby created and designated as the Empire-Strawn Gas Pool, consisting of the following described area:

IT IS FURTHER ORDERED THAT:


(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the

Division within said 60-day period shall subject the well to cancellation of allowable.


(2) The effective date of this order and all creations and extensions included herein shall be December 1, 1996.
