Re: Application of Manzano Oil Corporation for Compulsory Pooling, Lea County, New Mexico


Gentlemen:

This letter is to advise you that Manzano Oil Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of all mineral interests in the Wolfcamp formation in the S/2 NE/4 of Section 11, Township 16 South, Range 36 East, N.M.P.M., Lea County, New Mexico. Manzano proposes to dedicate the referenced pooled unit to its existing "SV" Double Eagle Well No. 1 at a previously approved unorthodox location 1500 feet from the North line and 2148 feet from the East line of said Section 11.

This application has been set for hearing before a Division Examiner on December 19, 1996. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
