




Gentlemen:

This letter is to advise you that Enron Oil & Gas Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking the authority to drill its proposed Bell Lake Unit Well No. 1 at a location 1980 feet from the South and East lines of Section 7, Township 24 South, Range 34 East, and dedicate thereto all previously compulsory pooled standard 320-acre spacing and proration units in and under the E/2 of Section 7.

This application has been set for hearing before a Division Examiner on January 23, 1997. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
