In accordance with the provisions of Division Order No. R-10848 entered on July 31, 1997, the Oil Conservation Division is reopening Case No. 11750 in order to give all operators in the Northeast Shoe Bar-Strawn Pool, Lea County, New Mexico, the opportunity to appear and show cause why the temporary special pool rules for the Northeast Shoe Bar-Strawn Pool should not be rescinded and said pool not be developed either on statewide 40-acre spacing or with an optional second well on each 80-acre unit.
