Dear Mr. LeMay:

On April 30, 1997, I received a copy of a letter dated April 28, 1997, signed by Paul R. Owen of the Campbell, Carr, Berge & Sheridan Law Firm conveying Mewbourne Oil Company's proposed Order in the above-referenced cases pertaining to the February 20, and April 3, 1997, Examiner hearings. At the conclusion of the April 3, 1997, hearing, Mr. Carr and I agreed that we would decide on a date for the submission of the proposed orders. This was done because of Mr. Carr's representation that he thought he could settle the dispute between Mewbourne and Bass. I had several subsequent conversations with Mr. Carr in which he again indicated that he thought he could settle the case and thus obviate the need for submitting a proposed order. Mr. Carr was advised that I was going to be out of the office from April 17, until April 28, 1997, for personal and medical reasons. Just prior to my leaving on April 17, I attempted to contact Mr. Carr to see what the status of his settlement attempts were. Mr. Carr did not return my telephone calls.

Receipt of the proposed order came as a complete surprise this morning. I am going to take the receipt of said letter as an indication that settlement is not possible. Because I have not worked on the proposed order and because of my being out of the office I am hereby giving notice that Bass
