


Dear Mr. Stogner:



Pursuant to NMOCD Rule 104(F), Manzano Oil Corporation requests administrative approval of an unorthodox well location in the N/2NE/4 of Section 12, Township 16 South, Range 36 East. Manzano proposes to drill its "SV" Kim Harris No. 3 Well at an unorthodox location 242 feet from the North line and 2148 feet from the East line of Section 12. The well will be drilled to a depth of approximately 11,800 feet to the Strawn formation, Northeast Lovington Pennsylvania Pool.

Manzano seeks an unorthodox location for geologic reasons. To date, three Strawn tests have unsuccessfully been attempted in the N/2NE/4 of Section 12. All three tests (Bridge Oil Kim Harris #1, Manzano Oil Kim Harris #2 and Middle Bay Oil Harris #2 - directionally drilled from the Manzano Kim Harris #2 wellbore) encountered tight, unproductive Strawn limestone. Exhibit 1 (Isopach map of Strawn Amplitude and Inversion Anomalies) shows that the 3-D seismic amplitude and inversion models predict that the Strawn will be porous and productive at the proposed unorthodox location. The Kim harris #3 location is positioned on the extreme southern boundary of the most porous section of this predicted Strawn anomaly (highlighted in green). At an orthodox location the Strawn appears to be tight and unproductive. For this reason Manzano Oil Corporation cannot drill its well at an orthodox location.

Also enclosed is a plat which shows the ownership of all leases offsetting the proposed spacing unit and all wells that have been completed thereon. Manzano has provided notice of this application to all of the operators of the offsetting units or working interest owners by certified mail. Copies of the letters to the offsetting operators or owners are attached hereto.


