

1. Relative Phyllis Jones provided the following information:
 - Harold and Medreth Fields married around 1948 in Gallup, NM
 - Harold worked for Sante Fe Railroad in Gallup, NM
 - Harold and Medreth moved to Winslow, AZ date unknown
 - Daughter Denise born in Winslow, AZ 7-6-51
 - Harold Died in 1974 in Hemet, California
 - Daughter Denise married to a man by last name Marshal
 - Denise Marshal and husband lived in Lacey Fort Lewis where he was stationed in service

2. 11/15/96
 - Credit check on Medreth Fields SS # 555-34-8692 showed address of:
7020 S. 12th Street Apt. 2901
Tacoma, WA 98465-1739
 - Apartment complex known as Lakeside Landings Apartments 206-564-5099
 - Called Lakeside Landings Apt.'s property management department and they could not confirm or deny that Medreth still resides at the address, however, if she does live in the complex they will notify her to contact Rob Johnston @ 970-247-3157.

3. Credit check on Medreth Fields revealed last address of 7020 South 12th Street, Apt. # 2901, Tacoma, Washington 98465-1739 as of 10-27-92. Mailed correspondce to last known address and it was returned "Addressee Unknown Return to Sender".

4. Contacted Lakeside Landings Apartments, Medreths address Apartment building, clerk would not confirm wether Medreth was still residing at Apartment complex.

5. 1/3/97
Information provided by Merrion Oil and Gas from Division of Interest files on other properties:
 - Last Will and Testament of Thomas Harold Fields, dated 2-5-63, Filed for probate 2-14-68, Bernalillo, NM. Hiers Listed are:
 - Medreth Delight Fields, Wife (also appointed as Executrix)
 - Dennise Delight Fields, Daughter (age at time of Will 9 years old)
 - Lance Monroe Fields, Son (age at time of Will 1 years old)

Jacqueline Campbell, named Trustee for the benifit of Dennise and Lance if Medreth predesease's Harold, and Jacqueline also named successor Executrix if Medreth predesease's Harold.

6. Contacted Jacqueline Campbell in Ouray, Colorado, she has not been in contact with Medreth or kinds since Thomas Harold Fields death in 1967. Jacqueline has no idea where Medreth lives or even if she is still living, and has no idea where the children are.

7. Contacted Pierce County, Takoma Washington State Health Department, Vital Stitistics Department and No Death Certificate Records found on Medreth Delight Fields in Pierce County from 1972 to 1-14-97.
