1 WHEREUPON, the following proceedings were had at
2 8:20 a.m.:

3 EXAMINER CATANACH: Bill, are we -- the Manzano
4 case?

5 MR. CARR: May it please the Examiner, on Case
6 11,790 we're requesting that the case be continued to July
7 the 10th and readvertised.

8 We have submitted an amended Application which
9 will reopen a previous case and, for the purpose of
10 presenting additional testimony concerning pooling of
11 several additional interests that were discovered after the
12 original order was entered, I don't know whether you prefer
13 to dismiss this case and then reopen the preceding one,
14 because that's what the Application sought and also what
15 the new amended ad seeks. So it's whichever you prefer.

16 But I have provided a new legal ad and requested
17 that it be included on the July 10th docket. And that case
18 is styled as a reopening of a previous application.

19 EXAMINER CATANACH: That should take care of it,
20 shouldn't it, the Application that you filed now to reopen
21 the previous case?

22 MR. CARR: The Application was correct, it was
23 just that the wrong legal ad was submitted, and it was an
24 error from my office.

25 EXAMINER CATANACH: So it wouldn't do any harm to

1 dismiss this case?

2 MR. CARR: And just have it docketed, and I
3 assume it has been, under the new ad that we've filed.

4 EXAMINER CATANACH: Under the new ad it's styled
5 as --

6 MR. CARR: And with the new ad it's consistent
7 with the Application.

8 EXAMINER CATANACH: It's styled as a reopen --

9 MR. CARR: Yes.

10 EXAMINER CATANACH: -- of the previous case --

11 MR. CARR: Yes.

12 EXAMINER CATANACH: -- so it doesn't have the
13 same case number?

14 MR. CARR: I don't believe so.

15 EXAMINER CATANACH: Okay. Well, I'll tell you
16 what, let's continue this to July 10th, and then at that
17 time we can dismiss one --

18 MR. CARR: Dismiss this and --

19 EXAMINER CATANACH: -- this one, or whatever we
20 need to do. So this case will be continued to July 10th.
