



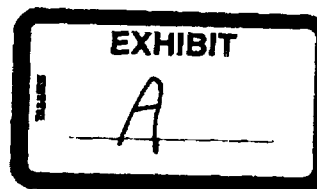

The application requested an unorthodox location in the Strawn formation for the Cayuma Well No. 1-A, with a bottom hole location 3807 feet from the south line and 1179 feet from the west line of Section 1, Township 16 South, Range 36 East, N.M.P.M., Lea County, New Mexico.
