

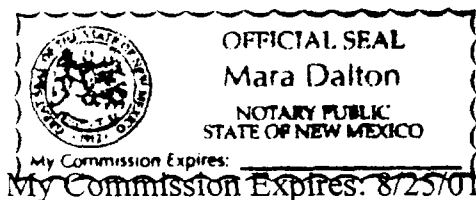


Gentlemen:

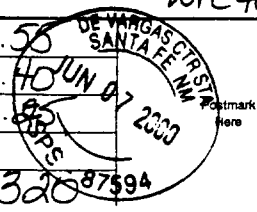

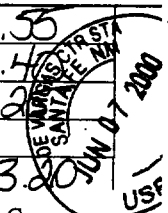
