Gentlemen:

Regarding the captioned well and proposed unorthodox location, Mewbourne Oil Company (Mewbourne) as an offset Operator waives objection to such well location subject to the following conditions:

- 1) In the event EOG Resources, Inc. (EOG) drills the captioned well, EOG agrees to a one time waiver of objection to a subsequent well (a well drilled to test the Pennsylvanian formation) Mewbourne proposes to drill in the adjoining S/2 of the captioned Section 7 wherein Mewbourne agrees to locate such well no closer than 360' from the North line of Mewbourne's S/2 spacing unit.
- 2) EOG agrees to furnish Mewbourne a copy of all logs, drillstem test information, Reservoir Formation Tests and daily drilling and completion reports as such information becomes available to EOG through sixty (60) days of official completion of EOG's captioned well. Likewise, Mewbourne agrees to furnish EOG the same information in the same timely manner for any subsequent well drilled by Mewbourne as referenced above.
- 3) Should the Oil Conservation Division or Commission place any restrictions or conditions on the drilling of the captioned well, and EOG drills said well, EOG reserves the right to seek the same restrictions or conditions on Mewbourne's well noted in paragraph 1 above.
