
Ladies and Gentlemen:

This letter is to advise you that Threshold development Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of all mineral interests from the surface to the base of the Wolfcamp formation in certain spacing and proration units the W/2 of Section 16, Township 24 South; Range 33 East, N.M.P.M.; Lea County, New Mexico. Threshold proposes to dedicate the referenced pooled units to a well which it proposes to drill to a depth sufficient to test all pooled formations to the base of the Wolfcamp formation, Johnson Ranch (Wolfcamp) Gas Pool, at a standard location in the NE/4 NW/4 of said Section 16.

This application has been set for hearing before a Division Examiner on January 25, 2001. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Prehearing Statement three days in advance of a scheduled hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.






