APPLICATION

Devon Energy Production Company, L.P. applies for an order abolishing the Special Rules and Regulations for the Buffalo Valley-Pennsylvanian Gas Pool (the "Pool"), and in support thereof, states:

 Applicant is an operator in the Pool, which was created by Oil Conservation Commission Order No. R-2349, dated October 31, 1962. The Pool currently encompasses the following acreage:

> Township 14 South, Range 27 East, N.M.P.M. Section 25: All Section 26: S1/2 Sections 35 & 36: All Township 14 South, Range 28 East, N.M.P.M. Section 31: All Township 15 South, Range 27 East, N.M.P.M. Sections 1 & 2: All Section 3: N½ Section 4: All Sections 11-14: All Section 15: EУ Section 22: Ε½ Sections 23-26: All Township 15 South, Range 28 East, N.M.P.M. Sections 6 & 7: All Section 8: $S\frac{1}{2}$ Section 16: Ε½ Section 17: All Section 18: NK Section 20: N1⁄2 Section 21: W½ and NE¼

2. Special Rules and Regulations for the Pool were adopted by Commission Order Nos. R-2349, R-2349-A, and R-1670-H. The rules require (a) 320 acre well units, (b) wells to be located in either the northwest quarter or the southeast quarter of a section, and (c) wells to be located no closer than 990 feet to the outer boundary of a section nor closer than 330 feet to a quarter-quarter section line.

3. The Pool was a prorated gas pool governed by Division Order No. R-1870, as amended. However, prorationing in the Pool has been suspended or terminated.

4. Applicant requests that the Special Rules and Regulations for the Pool be abolished, and that the Pool henceforth be governed by the Division's statewide rules.

5. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the relief requested above be granted.
