

CASE 12810: In the matter of the hearing called by the Oil Conservation Division for an order creating and extending certain pools in Chaves and Eddy Counties, New Mexico.

(a) CREATE a new pool in Chaves County, New Mexico classified as a gas pool for Atoka production and designated as the Broke Tank Lake-Atoka Gas Pool.
