in consideration of TEN AND OTHER DOLLARS in hand paid, receipt of which is here acknowledged, and I. Lesser, in consideration of TUN NND OTHER DOLLARS in hand paid, receipt of which is here acknowledged, and of the toyalties herein provided and of the agreements of the lessee herein contained, hereby grants, lesses and lets exclusively unto lessee for the purpose of investigating, emploring, prospecting, drilling, and operating for and producing oil and gas, injecting gas, waters, other fluids, and air into subsurface strate, leying pipelines, storing oil, building tanks, roadways, telephone lines, and other structures and things thereon to produce, save, take care of, treat, process, store and transport said minerals, the following described land in Lea County, New Mexico, to-wit:

Township 16 South, Range 35 East, N.M.P.M. Section 13: 3E/4
Section 23: SE/4

Section 24: NN/45N/4, NN/4NE/4

Section 25: N6/4 Section 26: NE/4

Said land is estimated to comprise 220.00 acres, whether it actually comprises more or less.

- 2. Subject to the other provisions herein contained, this lesse shall remain in force for a term of three (1) years from the produced from said land or from land with which said land is pooled.
- 3. The coyalties to be paid by lesses ere: (a) on oil, and other liquid hydrocarbons saved at the well, thressieteenths (1/16ths) of that produced and saved from said land, same to be delivered at the wells or to the credit of lessor in the pipeline to which the wells may be connected: (b) on gas, including casinghesd gas or other gaseous substance produced from said land and used off the premises or used in the manufacture of gasoline or other. products, the market value at the well of three-sixteenths (3/16ths) of the gas used, provided that on gas sold on or off the premises, the royalties shall be three-sixteenths (3/16ths) of the amount realized from such sale; (c) or off the premises, the coyalties shall be three-sixteenths [3/16ths] of the amount realized from such sale; (c) and at any time when this lease is not validated by other provisions hereof and there is a gas entifor condensate well on said land, or land pooled therewith, but gas or condensate is not being so sold or used and such well is shut in, either before or after production therefrom, then on or before 90 days after said well is shut in, and thereafter at annual intervals, lessee may pay or tender an advance shut-in royalty equal to \$1.00 per set acre of lesser's gas acreage then held under this lease by the party making such payment or tender, and so long as said shut-in royalty is paid or tendered, this lease shall not terminate and it shall be considered under all clauses hereof that gas is being produced from the leased premises in paying quantities. Each such payment shall be paid or tendered to the party or parties who at the time of such payment would be entitled to receive the royalties which would be paid under this lease if the well were in fact producing. The payment or tender of royalties and shut-in royalties made by check or draft. This is a paid-up lease and lessee shall not be obligated during the primary term hereof to commence or continue any operations of whatsoever character or to make any payments hereunder in order to maintain this lesse in force during the primary term; however, this provision is not intended to relieve lessee of the obligation to pay royalties on actual production pursuant to the provisions of Paragraph 3 hereof.
- 5. Lessee is hereby granted the right and power, from time to time, to pool or combine this lease, the land covered by it or any part or horizon thereof with any other land, leases, mineral estatus or parts thereof for the production of oil or gas. Units pooled hereunder shall not exceed the standard proration unit fixed by law or by the Oil Conservation Division of the Energy and Minerals Department of the State of New Mexico or by any other lawful authority for the pool or area in which said land is situated, plus a tolerance of ten percent. Leases shall the Oil Conservation Division of the Energy and Minerals Department of the State of New Mexico or by any other lawful authority for the pool or area in which said land is situated, plus a tolerance of ten percent. Lessee shall file written unit designations in the county in which the premises are located and such units may be designated from time to time and either before or after the completion of wells. If at the expiration of the primary term there is no well upon said land capable of producing oil or gas, but lesses has commenced operations for drilling or reworking thereon, this lesse shall remain in force so long as operations are prosecuted with no cassation of more than 60 consecutive days, whether such operations be on the same well or on a different or additional well or wells, and if they result in the production of oil or gas, so long thereafter as oil or gas is produced from said land. If, after the expiration of the primary term, all wells upon said land should bucome incapable of producing for any cause, this lesse shall not terminate if lesses commenced operations for additional diffing or for reworking within 60 days thereafter. Lesses shall have free use of oil, gas and water from said land, except water from lessor's wells and tanks, for all operations hereunder, and the royalty shall be computed after deducting any so used. - 8. The rights of either party hereunder may be essigned in whole or in part and the provisions bereaf shall extend to their heirs, executors, amministrators, successors and assigns; but no change in the ownership of the last



or in the ownership of, or rights to receive, royalties or shut-in royalties, however accomplished shell operate to sularge the obligations or diminish the rights of lessee; and no such change or division shell be binding upon leases for any purpose until 10 days after lessee has been furnished by certified sail at lessee's principal place of business with acceptable instruments or certified copies thereof constituting the chain of title from the original lessor. If any such change in ownership occurs through the death of the owner, lessee may, at its option, pay or tender any royalties or shut-in royalties in the name of the deceased or to his estate or to his heirs, executor or administrator until such time as lessee has been furnished with evidence satisfactory to lessee as to the persons entitled to such sums. Should lessee be prevented from complying with any express or implied dovenant of this lesse, or from conducting drilling or reworking operations hereunder, or from producing oil or gas hereunder by reason of scarcity or inability to obtain or use equipment or material, or by operation of force anjeure, or by any federal or state law or any order, rule or regulation of governmental authority, then while so prevented, lessee's duty shall be suspended, and lessee shall not be liable for failure to comply therewith; and this lease shall be extended while and so long as lessee is prevented by any such cause from conducting drilling or reworking operations or from producing oil or gas hereunder; and the time while lessee is so prevented shall not be counted against lessee, anything in this lesse to the contrary notwithstanding.
