GAS POOLING AGREEMENT

WHEREAS, under the terms of presently valid and subsisting oil and gas leases, a well for oil and gas production has heretofore been drilled in the center of the

Northeast Quarter of Northwest Quarter (NE1 of NW1) of Section 14, Township 24 South, Range 36 East, Lea County, New Mexico,
