Mr. Sprinkle,

As you are aware the application (Administrative Application Reference No. pKRV0-213545806) that you refer to was initially filed on May 15, 2001. On May 13, 2002 (2 days before the application was received by the Division) an objection was filed by Dugan Production Corp. This application was then set for an Examiner's hearing scheduled for June 13, 2002 (see my letter to you dated May 21, 2002). On June 7, 2002 your legal counsel, Mr. Jim Bruce, requested a continuance to the June 26th docket. Examiner David R. Catanach heard this disputed case at that time. As I understand it took approximately three hours for this case to be heard. The transcript in this matter has not been provided the Division due to the three days of hearings in Farmington last week. I of course can not speak for the examiner nor management but I expect a decision will not be made at this case in the next week. Further, I am not in a position to provide you an answer at this time.

Since this matter was contested (please see Rule 1223 concerning Ex Parte Communications) I suggest you contact Mr. Bruce for any additional information.
