13 commingling of production from certain Gallup pools in the
14 South Lybrook Gathering System operated by Questar. Notice
15 has been provided of this to Questar, they do not object,
16 and the case has been filed and styled in the absence of
17 objection it will be taken under advisement.

18 We're unaware of any objection and would request
19 that the Application be considered on the materials filed
20 with the Application, I believe, on August the 7th.

25 objection to Dugan's Application in this case and recommend
