APPLICANT'S STATEMENT OF CASE

Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation under the following acreage in irregular Section 1, Township 16 South, Range 34 East, NMPM, Lea County, New Mexico: Lots 1, 2, 7,8, 9, 10, 15 & 16 to form a standard 328.34-acre E/2 gas spacing and proration unit for all formations or pools spaced on 320 acres within this vertical extent, which presently include but are

not necessarily limited to the Undesignated Townsend-Morrow Gas Pool. This spacing and proration unit is to be dedicated to Arrington's proposed Triple Teaser Federal Com Well No. 1 to be drilled at a standard location 1200 feet from the North line and 1665 feet from the East line (Unit B) of irregular Section 1. Said area is located approximately 8 miles West of Lovington, New Mexico.


