("GWD") is named Operator under that certain Compulsory Pooling Order No. R-11869 of the State of New Mexico Energy, Minerals and Natural Resources Department Oil Conservation Division ("the Order") which covers drilling the captioned well and drilling unit for such well. The BLM records and Lea County records reflect that you own an 14.36119% interest in operating rights in the S/2NE/4, N/2SE/4 of Section 34 as to depths from the surface to the base of the Morrow formation. David H. Arrington Oil and Gas Inc. ("AOG") has informed us and represented at the hearing before the NMOCD that resulted in the Order that it has acquired your interest in this unit and well under an agreement not recorded in the Lea County records.
