IN THE MATTER OF:

The application of the Oil Conservation Commission of New Mexico upon its own motion for an order for the creation of new pools and the extension of existing pools in Lea, Chaves and Eddy Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such creations and extensions should not be made as follows:

(a) Create a new pool in Chaves County, New Mexico, classified as an oil pool for Wolfcamp production, designated as the Apache Springs Wolfcamp Pool, and described as:

> Twp. 11 South, Rge. 30 East E/2 Section 12

> > Case No. 906

Twp. 11 South, Rge 31 East W/2 Section 7

and such other contiguous lands as may properly) be included therein as supported by proper) testimony and recommendations adduced at said) hearing.

(b) Extend the High Lonesome Pool boundary in Eddy County, New Mexico, to include therein:

> Twp. 16 South, Rge. 29 East NW/4 Section 16

and such other lands contiguous to said pool as) may properly be included therein as supported) by proper testimony and recommendations adduced) at said hearing.

(c) Extend the Anderson Ranch-Devonian Pool boundary in Lea County, New Mexico, to include therein:

> Twp. 16 South, Rge. 32 East Lots 13, 14, 15 and 16 of Section 2

and such other lands contiguous to said) pool as may properly be included therein as) supported by proper testimony and recommendations adduced at said hearing.

(d) Extend the Crossroads Pool boundary) in Lea County, New Mexico, to include therein:

Twp. 9 South, Rge 36 East E/2 Section 26

and such other lands contiguous to said) pool as may properly be included therein as) supported by proper testimony and recommendations adduced at said hearing.

(e) Extend the Denton Pool boundary in Lea County, New Mexico, to include therein:

Twp. 14 South, Rge 37 East E/2 Section 25

and such other lands contiguous to said) pool as may properly be included therein as supported by proper testimony and recommendations adduced at said hearing.

(f) Extend the Denton - Wolfcamp Pool boundary in Lea County, New Mexico, to include therein:

Twp. 14 South, Range 37 East NW/4 Section 25

and such other lands contiguous to said) pool as may properly be included therein as) supported by proper testimony and recommendations adduced at said hearing.

(g) Extend the Mescalero-Devonian Pool boundary in Lea County, New Mexico, to include therein:

Twp. 10 South, Rge 32 East SE/4 Section 27

and such other lands contiguous to said) pool as may properly be included therein as) supported by proper testimony and recommendations adduced at said hearing.

(h) Extend the Vacuum Pool boundary in) Lea County, New Mexico, to include therein:)

Twp. 17 South, Rge. 33 East SE/4 Section 36 and such other lands contiguous to said pool as may properly be included therein as supported by proper testimony and recommend-) ations adduced at said hearing. (i) Extend the Blinebry Gas Pool boundary in Lea County, New Mexico, to include therein: Twp. 21 South, Rge. 37 East SW/4 Section 25; E/2 Section 26 and such other lands continguous to said pool as may properly be included therein as) supported by proper testimony and recommendations adduced at said hearing. TRANSCRIPT OF HEARING

MR. MACEY: The hearing will come to order, please. The next case is Case 906. Mr. Rhodes?

MR. RHODES: I would like to have Mr. Stanley sworn in this case.

S. J. STANLEY,

called as a witness, having been previously duly sworn, testified as follows:

DIRECT EXAMINATION

By MR. RHODES:

- Q Will you state your name and position for the Commission?
- A S. J. Stanley, Engineer for the Oil Conservation Commission.
- Q Mr. Stanley, in connection with Case 906, pertaining to

A Yes, sir. I recommend that new pools be created as advertised, and extensions made to existing pools as advertised.

Without objection they will be introduced in evidence. Any questions of the witness? All of the proposed extentions are exactly as advertised, no changes?

A Yes, sir.
