called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

By MR. RHODES:

- Q State your name and position for the Commission, please.
- A Elvis A. Utz, Engineer for the Oil Conservation Commission.
- Q Mr. Utz, in connection with Case 907, pertaining to the nomenclature of gas pools in Northern New Mexico, do you have any recommendations you would like to make as to the subject matter set out in this case?
 - A Yes, I have.
- Q Will you state your recommendations and give the basis for these recommendations?
- A Yes, I will. All my recommendations have to do with the Aztec Pictured Cliffs Pool, and I recommend that all these recommendations be adopted as advertised.
- Q Mr. Utz, have you prepared an exhibit in connection with this case?
 - A Yes, I have.
 - Q Would you describe those exhibits to the Commission, please?
- A I have an exhibit which lists all the extensions as advertised, together with the wells on which these recommendations are based. I have also added to this exhibit, one location which has not been advertised, and which I will read into the record and recommend that it be adopted as part of the Aztec-Pictured Cliffs pooling. This is Township 29 North, Range 11 West, Section 5, southeast quarter. This extension is based on the El Paso Natural

Gas Company pool Unit No. 2, which is located in the southeast quarter of Section 5, Township 29 North, Range 11 West, with an IP of 1,032,000 MCF.
