Dear Mr. Spurrier:

A meeting of the Southeastern New Mexico Nomenclature Committee was held in Hobbs, June 7, 1950, at which time it was voted upon to make the following recommendations to the Oil Conservation Commission:

- ✓ 1. Create a new pool named "BROWN" for Queen-Grayburg production to include all of Sec. 26-T10S-26E, for the Brown #1 State well located 1980' N and W lines of Sec. 26-T10S-R26E, Chaves County, TD 1700, PB 777.
- ✓ 2. Create a new pool named "DENTON-WOLFCAMP" for Wolfcamp production around Denton pool to include Secs. 11, 12, 13, and 14, of T15S-R37E, for the Atlantic #1 Dickinson "B" located 1980' S and 660' W lines of Sec. 12-T15S-R37E. TD 9420, TP 9395, IPF 177 BOPD on 20/64" choke. Completed 2-26-50.
- ✓ 3. Create a new pool named "DENTON-MISSISSIPPIAN?" for Mississippian? production to include Secs. 11, 12, 13, and 14, of T15S-R37E, for the Atlantic #1 Dickinson "A" located 660' N and W lines of Sec. 13-T15S-R37E. TD 11,325, TP 11,240, IPF 305 BOPD. Completed 12-9-49.
