Dear Jason:

Thanks for your letter of October 16 advising that the Amerada State BTK #1 and the Continental Oil Company Warren B 27 #1 have been incorporated into pools under Case 303. Apparently, this case was heard in August and I do not have a copy of the docket for that hearing.

I am enclosing a copy of form C-123 on the Sinclair Oil & Gas Company Boyd #2 as per your request. I am also enclosing a copy of my letter to the Spartan Drilling Co. concerning form C-123 on their Federal #1.

I have also checked the well files on the McMillian & Peterson State A #1 and the Honolulu State #1 both of which are located in Unit J of Section 13-11-27. The well records indicate that the Honolulu State #1 is producing from 6490 to 6563 feet and the McMillian & Peterson State A #1 is producing from 2025 to 2042 feet. The wells are therefore producing from separate formations and each is entitled to a 40 acre allowable for its particular depth range. It will therefore be in order to create a new pool for the McMillian & Peterson well. I see no objection to following the suggestion of the operator and naming the pool Chisum San Andres.
