ORDER OF THE COMMISSION

BY THE COMMISSION:

It appearing to the Commission that Order No. R-128-A heretofore entered in this cause is not a correct memorial of the judgment as rendered and announced by the Commission under date of November 10, 1953, by reason of clerical error, in that the order read as follows:

"It Is Therefore Ordered:

(1) That the applicant, Stanolind Oil and Gas Company, Southern Union Gas Company, Southern Union Gathering Company, and El Paso Natural Gas Company, or either or all of them, on or before December 1, 1954, provide the Commission with a true copy of each and all agreements negotiated between the purchasing companies represented as beginning September 1, 1953, and designed to provide equitable withdrawal of gas from all wells in the Blanco-Mesaverde Pool."

when it should have read as shown below:

"It Is Therefore Ordered:

(1) That the applicant, Stanolind Oil and Gas Company, Southern Union Gas Company, Southern Union Gathering Company, and El Paso Natural Gas Company, or either or all of them, on or before February 1, 1954, provide the Commission with a true copy of each and all agreements negotiated between the purchasing companies represented as beginning September 1, 1953, and designed to provide equitable withdrawal of gas from all wells in the Blanco-Mesaverde Pool."

IT IS THEREFORE ORDERED:

That Order R-128-A heretofore entered by this Commission in the above-entitled cause on November 10, 1953, be and the same hereby is corrected to conform to the actual judgment as rendered by the Commission by correcting and modifying above-stated Section (1) of the order portion to show the date February 1, 1954, instead of December 1, 1954, and said Order R-128-A in all other respects is hereby ratified and confirmed; and

IT IS FURTHER ORDERED: That this order correcting the record of said order be entered nunc pro tunc as of the 10th day of November, 1953, that being the date when said Order R-128-A was originally made and entered.
