ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a. m., March 20, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 11th day of April 1952, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing and being fully advised in the premises:

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That a new pool should be created, classified as an oil pool, and designated as the Teague-Devonian pool, described as:

T. 23 S, R. 37 E, NMPM
All of sections 26, 27, 34 and 35

(3) That a new pool should be created, classified as an oil pool, and designated as the Maljamar-Devonian pool, described as:

T. 17 S, R. 32 E NMPM
E/2 sec. 21; all of sec. 22

(4) That a new pool should be created, classified as an oil pool, and designated as the Wantz-Abo pool, described as:

T. 21 S, R. 37 E NMPM
S/2 section 21

(5) That the South Saunders pool, Lea County, New Mexico, as heretofore classified, defined, and described, should be extended to include:

T. 15 S, R. 33 E, NMPM
All of sec. 19

(6) That the Saunders pool, Lea County, New Mexico, as heretofore classified, defined, and described, should be extended to include:

T. 14 S, R. 33 E, NMPM
S/2 sec. 10 and all of sec. 15

(7) That the West Dollarhide pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 24 S, R. 38 E, NMPM
Lots 1, 2, 3 and 4 in sec. 33

T. 25 S, R. 38 E, NMPM
Lots 1 and 4 in sec. 4

(8) That the Brunson pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 21 S, R. 37 E NMPM
SE/4 sec. 2

(9) That the Turkey Track pool, Eddy County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 19 S, R. 29 E, NMPM
SE/4 sec. 9

(10) That the Lovington-Abo pool, Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include:

T. 16 S, R. 37 E, NMPM
All of sec. 32 and W/2 sec. 33

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission, be, and the same hereby is approved, as follows:

(1) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Teague-Devonian pool and described as follows:

T. 23 S, R. 37 E, NMPM
All of sections 26, 27, 34 and 35

(2) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Maljamar-Devonian pool and described as follows:

T. 17 S, R. 32 E, NMPM
E/2 sec. 21; all of sec. 22

(3) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Wantz-Abo pool and described as follows:

T. 21 S, R. 37 E, NMPM
S/2 sec. 21

(4) That the boundaries of the South Saunders pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 15 S, R. 33 E, NMPM
All of sec. 19

(5) That the boundaries of the Saunders pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 14 S, R. 33 E, NMPM
S/2 sec. 10 and all of sec. 15

(6) That the boundaries of the West Dollarhide pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 24 S R. 38 E, NMPM
Lots 1, 2, 3 and 4 in Sec. 33

T. 25 S, R. 38 E, NMPM
Lots 1 and 4 in sec. 4

(7) That the boundaries of the Brunson pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 21 S. R. 37 E, NMPM
SE/4 sec. 2

(8) That the boundaries of the Turkey Track pool, Eddy County, New Mexico, be, and the same hereby are extended to include:

T. 19 S, R. 29 E, NMPM
SE/4 sec. 9


(9) That the boundaries of the Lovington-Abo pool, Lea County, New Mexico, be, and the same hereby are extended to include:

T. 16 S, R. 37 E NMPM
All of sec. 32; W/2 sec. 33
