ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. , February 17, 1953, at Santa Fe, New Mexico before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 10th day of March 1953, the Commission, a quorum¹ being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That a new pool should be created, in Lea County, New Mexico, classified as an oil pool, for Pennsylvanian production, designated as Edison-Pennsylvanian, and described as:

Township 16 S, Range 35 E, NMPM
All of Section 18

(3) That a new pool should be created, in Lea County, New Mexico, classified as an oil pool for Wolfcamp production, designated as the Lovington-Wolfcamp Pool and described as:

Township 16 S, Range 36 E, NMPM
S/2 Sec. 23; N/2 Sec. 26.

(4) That a new pool should be created, in Eddy County, New Mexico, classified as an oil pool for Castile production, designated as the Glenn-Castile pool and described as:

Township 26 S, Range 27 E, NMPM
All Section 29.

(5) That the Corbin pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

(12) That the North Shugart pool boundary in Eddy County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

(13) That the Saunders pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 16 S, Range 36 E, NMPM
S/2 Section 23; N/2 Section 26.

(3) That a new pool, be, and the same hereby is created, designated for oil production, denominated the Glenn-Castile Pool, Eddy County, New Mexico, and described as follows:

Township 26 S, Range 27 E, NMPM
All of Section 29.

(4) That the boundaries of the Corbin Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 17 S, Range 33 E, NMPM

(5) That the boundaries of the Crossroads-Pennsylvanian Pool, Lea County, New Mexico, be, and the same hereby are extended to include:
