DIRECT EXAMINATION

BY MR. WHITE:

Q Will you state your full name, please, stating your last name first?

Q Mr. Stanley J. Stanley, in your capacity as an engineer for the Oil Conservation Commission, have you had occasion to make a study of the nomenclature case as publicized in Case No. 561, involving extensions in the Lea and Eddy County Pools?

Q Will you give a report to the Commission of your studies, together with your conclusion and recommendation?

A In addition to the advertised extensions, I have one exception in Case 561, paragraph (f). The advertised extension included the extension to Section 30 in Township 18 South, Range 39 East. In addition to the advertised Section 30, I would like to include and recommend it extend to the East Hobbs - it extend the East Hobbs-San Adres Field to the North half of Section 31 to include the Velma Petroleum Corporation Penol Goode No. 1, Unit B in Section 81 18-39.

MR. WHITE: I think that ought to be readvertised before including it.

MR. GRAHAM: That is taken care of here. It says: "other lands as are contiguous."

MR. WHITE: That is contiguous to Section 30?

A Yes, sir.

MR. WHITE: Do you have any exhibit you wish to offer?

A Yes, sir.

MR. WHITE: Without objection, it will be admitted.
