OF EXISTING POOLS IN SAN JUAN AND SANDOVAL  
COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 15, 1954.  
at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico,  
hereinafter referred to as the "Commission".

NOW, on this <sup>19<sup>th</sup></sup> day of May, 1954, the Commission, a quorum being  
present, having considered the testimony presented and exhibits received at  
said hearing,

FINDS:

(1) That due public notice having been given as required by law,  
the Commission has jurisdiction of this case and the subject matter thereof.

(2) That the West Blanco-Dakota Pool in San Juan County and the  
Media-Entrada Pool in Sandoval County, New Mexico, should be created as ad-  
vertised.

(3) That extensions as advertised should be approved for the fol-  
lowing pools in San Juan County, New Mexico: Fulcher-Kutz - Pictured Cliffs,  
West Kutz - Pictured Cliffs, West Kutz-Dakota, Aztec-Pictured Cliffs and  
South Blanco-Pictured Cliffs.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and it  
hereby is approved, as follows:

(a) That a new pool be created in San Juan County, New Mexico, classi-  
fied as a gas pool for Dakota production, designated as the West Blanco-Dakota  
Pool, and described as:

Township 32 North, Range 12 West, NMPM  
W/2 Section 29; all Section 30;  
N/2 Section 31; NW/4 Section 32

(b) That a new pool be created in Sandoval County, New Mexico,  
classified as an oil pool for Entrada production, designated as the Media-  
Entrada Pool, and described as:

Township 19 North, Range 3 West, NMPM  
Sections 14 and 15, all;  
N/2 Section 22; N/2 Section 23

(c) That the Fulcher-Kutz - Pictured Cliffs Pool boundary as here-  
tofore classified, defined and described, should be extended to include therein:

Township 23 North, Range 10 West, NMFM  
All of Sections 13 and 14;  
N/2 Section 15; E/2 Section 23;  
all Section 24; N/2 Section 25

Township 30 North, Range 11 West, NMFM  
SW/4 Section 32

(d) That the West Kutz-Pictured Cliffs Pool boundary as heretofore classified, defined and described, should be extended to include therein:

Township 28 North, Range 13 West, NMFM  
NE/4 Section 22; N/2 Section 23

Township 29 North, Range 13 West, NMFM  
N/2 Section 28

(e) That the West Kutz-Dakota Pool boundary as heretofore classified, defined and described, should be extended to include:

Township 27 North, Range 12 West, NMFM  
N/2 Section 4; all Section 5;  
S/2 Section 6; all Section 7;  
N/2 Section 8

Township 28 North, Range 12 West, NMFM  
S/2 Section 28; all Sections 32 and 33

(f) That the Aztec-Pictured Cliffs Pool boundary as heretofore classified, defined and described, should be extended to include:


Township 30 North, Range 12 West, NMFM  
E/2 Section 13


(g) That the South Blanco-Pictured Cliffs Pool boundary as heretofore classified, defined and described, should be extended to include:


Township 27 North, Range 8 West, NMFM
